












### **PERA Benefit Payments**

- •Total benefit payments are concentrated in the Metro Denver region (see Figure 4)
- •Per capita measure demonstrates payments are important to all regions (Figure 5)
- •PERA payments are especially important in rural regions such as Pueblo-Southern Mountains region where these payments amount to over \$1,100 per month per person (i.e., when measured by all persons in the region, not only PERA recipients


When measured against total payroll, benefit payments amount to 3.3% at the state level, and for rural areas, such as the Pueblo-Southern Mountains and San Luis Valley Regions, amount to 14.3 and 12.1% of local payroll respectively

•PERA Benefits represent a larger share of the local economy in less populated regions including the San Luis Valley, Pueblo-Southern Mountains, and Eastern Regions,


•In more affluent or urban areas, this percentage is less than ten percent (10%); however for a substantial number of rural counties, PERA benefits are in the range of 10 to 25 percent, with some notable exceptions including the counties of Costilla (56.7 percent), Conejos (43.8 percent), Custer (31.3 percent) and Fremont (27.6 percent)



### Value-Added for State and Regions

Total impacts are greater in the more populated regions, but the per capita impacts are more comparable among regions with exception of the Pueblo-Southern Mountains region where the per capita impact is substantially greater.

Total Value-Added for State and Regions (dollars in millions)



Per Capita Value-Added for State and Regions



(dollars in millions)



Per Capita Labor Income for State and Regions



Components of the Colorado Economy




#### **Value-Added** by Industry Sector Pueblo-Southern Mountains




#### **Labor Income** by Industry Sector Pueblo Southern Mountains




